## Highlight Report from the Altarnun Parish Council Meeting on Wednesday, 3<sup>rd</sup> April 2019, Bolventor Reading Room.

**Attendance:** Councillors C Dowler, C Bloomfield, D Branch. CCllr A Parsons & Parish Handyman P Smart. Several residents and Todda Park applicant Mr Bettison & his architect Mr Hunt were also present.

Absent: Councillors N Jasper, J Kendall, T Hoskin, M McCallum, P Smith, L Baker-Pannell, C Richards & W Smith.

Also absent on scheduled vacation was M Savage, Parish Clerk. Notes taken by Cllr Branch in her absence.

**Point of Order:** Insufficient Parish Councillors were present for the meeting to be quorate & decisions to be taken. The Chair expressed disappointment at the unexpected level of non-attendance of Councillors at the meeting.

Cornwall Cllr Update: CCllr Parsons gave a brief update on litter clearance on A30. He was chasing Highways England to complete it. He was also pursuing with Cormac the two road safety issues raised at Bolventor in recent meetings. Finally, he enquired after the status of the recent enquiry into the clearance and re-opening of the St Nonna Holy Well site in Altarnun. Cllr Branch advised that it was her understanding from the Clerk's pre meeting briefing that the St Nonna's PCC had confirmed that the well was the acknowledged property of/owned by the Dioscese of Truro and talks were now underway as to whether any project to re-instate it should be PCC/Church led rather than APC led, although the APC were happy to continue to offer what support they could for any scheme formulated.

## **Public Representation:**

\*\* There was a general discussion between the Councillors present, residents, the applicant & his architect on the registration on the CC Planning website of objections to the planning application PA19/01306 for two dwellings with septic tank on land at Todda Close, Bolventor. The applicants Architect had also written to the Planning Office. After a lengthy but constructive debate the meeting accepted that no further action could be taken at this time and a formal decision from CC Planning Dept. was now awaited.

## Miscellaneous:

The Cllrs present briefly ran through the agenda items. Mr Smart discussed continuing problems with the emptying of the higher Trewint Dog Bin which did not appear to have been successfully registered on CC bin listings. The Clerk would be pursuing upon her return.

There was a general reprise upon progress being made on the new toilet block and the outstanding actions & potential opening dates and procedures, but a full discussion would take place at the next meeting.

The scheduled consideration of planning application **PA19/02007** for the residential extension to dwelling Oak Barn, South Carne, Launceston by Mr & Mrs S & J Gillbard was deferred until the next meeting which will be on Wednesday, 6<sup>th</sup> May 2019 at 7.30pm in Altarnun Village Hall.
