The Extraordinary Meeting had been called to consider multiple planning applications. The APC does not normally hold a meeting in August. Thank-you to all who attended.

There was a late addition to the agenda planning application PA19/06492 and the removal of the planning application PA19/01781/PREAPP as consultee comment not sought.

The meeting quickly turned to the planning application with the members of the public making representations to their relevant applications.

The APC considered the following planning applications & raised NO OBJECTIONS:-

** PA19/02007 revised residential extension to existing dwelling known as Oak Barn, South Carne, Mr & Mrs Gillbard . Decision proposed by Cllr P Smith, seconded by Cllr Hoskins & supported by all.

**PA19/05597 outline application for 2 'drive thru' fast food restaurants Plusha, Mr I Scott.

Mr I Scott & his Planning and Development Advisor, Mr P Wonnacott, presented the application. There was a lengthy discussion regarding traffic & safety at the Plusha Junction. The applicant stated a Traffic Assessment report was being sought. Several Cllrs expressed their concerns regarding increases in vehicles using the site & junction. Several Cllrs acknowledged the potential job opportunities the businesses would provide. Decision proposed by Cllr Hoskins, seconded by Cllr Kendall. Supported by Cllrs Jasper, Bloomfield, P Smith, and W Smith. Cllrs Richards & McCallum objected to the proposal. Cllr Branch abstained.

**PA19/05978 reinstatement of a single dwelling, Trevague, Trebatha Estates Ltd.

The application was outlined by Mr B Wood from Savills on behalf of the Trebathe Estate. **Decision** proposed by Cllr Bloomfield, seconded by Cllr Hoskins & supported by all.

**PA19/05287 custom build dwelling, Laurelin, Mr& Mrs Potter.

The application was outlined by Mrs J Graham on behalf of Mr & Mrs Potter. **Decision proposed by** Cllr Hoskins, seconded by Cllr Jasper & supported by all.

**PA19/06492 provide base for & locate static mobile home for a relative, Peggy's Barn, Lower Tregunnon, Mr & Mrs Soanes. Decision Proposed by Cllr Jasper, seconded Cllr Kendall & supported by all.

There was an update on the Toilet Block. Issues with the water connection are being dealt with. It now looks unlikely that they will be completed as hoped for Fun Week.
